

General Release of Liability and Assumption of all Risks
Applying to participants attending “OsstidBurn 2018” (the EVENT)

I, on behalf of myself, my heirs, executors, administrators, and assigns, hereby waive, release, discharge, and agree not to sue “Organisme de décompression des Brûleurs de Montréal” (the ORGANIZERS), Burning Man Project, Black Rock City LLC or other participants, and if applicable, owners and lessors of equipment, art installations, and premises used to conduct the EVENT or related activities (collectively the “Releasees”), from any and all claims for damages, injuries, losses, liabilities, and expenses that I may have or that may subsequently accrue to me relating to, resulting from, or arising out of my participation in the EVENT, including in any programs, events, art installations, or activities at the EVENT, and including any injury or damage to my person or property, or to that of any other person or property. If any claim is filed against me, however, I may file a counterclaim related to the same facts and circumstances. I agree to indemnify, defend, and hold the Releasees harmless from and against any and all claims by third parties for damages, injuries, losses, liabilities, and expenses relating to, resulting from, or arising out of my participation in the EVENT, including in any programs, events, art installations, or activities at the EVENT. I intend that the waiver and release of liability contained in this agreement shall be construed broadly to provide a release and waiver to the maximum extent permissible under applicable law.

1. I, the undersigned participant, wish to attend the “OsstidBurn 2018” event, taking place between June 14st, 2018 and June 17th, 2018, (hereafter referred to as “the EVENT”), and do so assuming full responsibility for my own safety at all times while at the EVENT and assume all risks associated with attending.
2. I understand and acknowledge that there is a river on property of the EVENT that is only accessible between dawn and dusk, that entering the river at any time is done at my own risk of injury, drowning or other harm and that the area is not supervised in any way.
3. I understand and agree to abide the SOUND LIMITS in place at the event: Loudspeakers must be pointing due South, and SPL may not exceed 100dBA (slow response) 10 meters from the speaker between 10 AM and 3 AM. Outside these time periods, SPL at 10 meters must be maintained at 80dBC (slow). Further, I understand and agree that the ORGANIZERS may request that any sounds be reduced or stopped if sound levels pose a problem for the EVENT, the VENUE or neighbouring residents.
4. I understand and agree to remain within the posted boundaries of the VENUE while attending the EVENT.
5. I understand that (1) I must bring enough food, water, shelter, and first aid to survive the duration of the Event; (2) guns, fireworks, rockets, and other explosives are prohibited; (3) handheld lasers of any kind are prohibited, and mounted lasers allowed only with the express permission of the ORGANIZERS; (4) this is a LEAVE NO TRACE, pack it IN, pack it OUT event and I am expected to cleanup my own camp and contribute to cleaning up the VENUE before departing the EVENT.
6. I understand that some participants at the EVENT may engage in expressive activity and dress, including nudity, vulgarity, provocative art or other expressive activities that would rarely be encountered outside of the EVENT or equivalent festivals and do knowingly agree to expose myself to this environment.
7. I certify that I am physically able to participate in the EVENT and in any associated activity or performance, and that I have not been advised otherwise by a qualified medical professional.
8. I understand and acknowledge that the nature of the EVENT includes dangers due to, but not limited to, terrain, flora, fauna, weather, vehicles, campfires, other participants, art structures, fire performances and smoke.
9. I understand and agree that no commercial activities are to take place on site, nor will any media (such as images, video or audio) created at the VENUE during the EVENT be used for commercial purposes.
10. I understand that if at any point the ORGANIZERS deem my behavior to be dangerous to myself, others or the VENUE, or breach the terms of this agreement in any way, the ORGANIZERS or their representatives may require that I leave the event and that no refund will be provided.
11. I agree and request that should any portion of this agreement be deemed invalid under the law, all remaining points of the agreement remain in full effect.
12. I understand and agree that the governing law of this agreement is that of the province of Quebec and the English version of the agreement to be used in case of any discrepancy between versions in other languages.
13. I understand that this General Waiver, Release and Assumption of risk shall be binding upon me, my heirs, executors, administrators,
14. I understand that children under 18 years of age can attend the event only accompanied by a parent or guardian, and that if I bring a minor to the event I agree to this General Release of Liability and Assumption of all Risks on their behalf, and do so as their biological parent or legal guardian.
